

#### **Success stories**

#### Release and resettlement for disabled prisoner

Our Community Care Caseworker successfully obtained a direction for release on parole for a disabled prisoner who had been imprisoned for 30 years. He is elderly and infirm and has a heart condition, reduced mobility, and was also demonstrating significant cognitive decline – including a drastically impaired short-term memory. She secured a comprehensive community care package providing a suitable release address. This enabled the parole panel to direct his release and to enable him to resettle successfully in the community. His placement is a specialist supportive care home that specifically supports those who are institutionalised. Our Caseworker has also initiated arrangements for him to receive mentoring in the community from an ex-prisoner.

#### Securing care after release for vulnerable woman prisoner

Our Women Prisoners Caseworker acted for a prisoner detained in a low secure psychiatric hospital. Even though she was considered well enough by a Mental Health Tribunal to be released from hospital, she needed to be released by the Parole Board before she could be discharged into the community. Her local authority rejected the application for the cost of her post-release accommodation and care support services in the community.

Our Caseworker corresponded with the local authority, setting out the woman's legal rights and putting them on notice that judicial review proceedings would be instigated if funding was not agreed. The local authority then agreed to provide the funding. This case highlights the difficulties that women prisoners with mental health conditions can face in obtaining the discharge care packages they require upon release.

#### Caseworker appointed to NICE committee

Our Women Prisoners' Caseworker, Naomi Lumsdaine, has been invited to be a professional member of the Development Group for a new NICE (National Institute for Heath and Care Excellence) guideline on mental health of adults in contact with the criminal justice system. The guideline will address the identification and management of mental health problems for adults from their first contact with police, through the court system, during a prison sentence and under supervision in the community, either on a community sentence or following release on licence. As a legal representative member, Naomi will draw on her experience assisting women prisoners detained in prisons and hospitals.

### Visit to Huntercombe prison

Our Outreach Caseworker attended Huntercombe prison in Oxfordshire in February to speak to prisoners being trained by the St Giles Trust organisation to act as Peer Advisers. Huntercombe houses only foreign nationals and our Caseworker's talk, which was followed by a lively discussion, was structured to relate to the specific needs of this group of prisoners. This includes the difficulties that foreign national prisoners who are very low security face in obtaining Category D status which will allow their transfer to an open prison, due to the complex interplay between prison and immigration procedures.
