Prisoner with Autism Spectrum Disorder Transferred to a Safer Prison

Prisoner A's mother emailed PAS on her son's behalf to report that he was being mistreated in prison. He had suffered a breakdown and had been in solitary confinement for more than 70 days, by which time he had been found naked, covered in his own excrement, and refusing to move.

Prisoner A suffers from a range of mental health conditions including Autistic Spectrum Condition (ASC) and Attention Deficit Hyperactivity Disorder (ADHD), both of which are proven to be negatively affected by solitary confinement. He had also been prescribed psychiatric medication. However, the prison governor did not acknowledge the ASC diagnosis, despite it being in Prisoner A's medical records. Prisoner A's mother had requested a mental health intervention on numerous occasions, yet the prison did nothing.

PAS sent Prisoner A a form of authority to sign, which granted his mother power of attorney and allowed PAS to act on his behalf. PAS

then contacted the prison governor directly, stressing Prisoner A's mental health issues and seeking transfer to a safer prison. As a result of our intervention, Prisoner A was transferred to a safe prison early the next morning. PAS received a card from the prisoner's mother, thanking us for the work we had done on behalf of her son and saying that she thought we had helped to save her son's life.
