News: PAS Helps Elderly Disabled Prisoner to be Relocated to Reasonably Adjusted Cell

PAS received a call to our Advice Line from a 70 year old woman prisoner. The prisoner had previously suffered two strokes, which affected her mobility and necessitated her use of a zimmer frame. She also suffered from osteoarthritis, a duodenal ulcer, angina, high blood pressure and poor vision.

The prisoner had been moved from a properly modified, disabled, cell in the prison without explanation. Put on normal location, she struggled to access the toilet using her zimmer frame, causing her to fall and resulting in further significant pain. She was then forced to use incontinence pads, which she was not able to change regularly, causing humiliation and degradation.

We wrote to the prison setting out the unlawful disability discrimination she was experiencing, in the form of breaches to the Equality Act 2010. We requested she be re-located urgently to a

modified, disabled, cell, which would permit the proper use of her zimmer frame in accordance with her basic human rights. We also requested a Care Assessment from Social Services and an urgent doctor's appointment.

The prisoner was almost immediately returned to a disabled cell, was given a doctor's appointment and was assessed by the local Adult Social Care Team. A Care Plan for the prisoner is now in place.



Latest Official COVID-19
Statistics Published by MOJ

On 13 November, the Ministry of Justice (MOJ) published statistics detailing the spread of COVID-19 in the prison and probation service in England and Wales up to 30 October.

The key findings listed in the document are:

• 55 prisoners, children in custody and probation service users have died having tested positive for COVID-19 or where there was a clinical assessment that COVID-19 was a contributory factor in their deaths. Of whom 32 were prisoners and 23 were probation service users.

Participants included author of the kits, Stuart Withers, Barrister at No 5 Chambers, Sarah Lamble, founding member of the Bent Bars Project and Reader in Criminology & Queer Theory at Birkbeck, University of London and Dean Kingham, solicitor at Swain and Co and a Committee member for the Association of Prison Lawyers. The discussion was Chaired by former PAS co-Director, Deborah Russo.

We are already sending the two kits out to prisoners and the response to both, as well as to the event, has been universally positive. The talk was recorded and can be viewed below:



Welcome Back Buffy!

PAS was saddened to bid farewell to our Fundraising and Communications Officer, Sara McCallum, who left for pastures new on Friday 20 November. However, we were delighted to welcome back Buffy

Five deaths of prisoners occurred in October 2020, the first deaths of service users since June 2020.

- Of the 55 deaths, 50 were suspected or confirmed to be caused by COVID-19, 28 were prisoners and 22 probation service users.
- 1,529 prisoners or children have tested positive for COVID-19 since the start of the 99 pandemic. across establishments, almost all of whom were adults. The number of new monthly confirmed cases has increased by 883 since September 2020. 45 establishments had prisoners or children testing positive in October 2020.
