Dear Friend of PAS

This has been highlighted by comments included in the recent inspections of HMPs Berwyn, Featherstone and Onley. We hope to see improvements soon and, in the meantime, PAS' caseworkers will continue to support prisoners in every way they can.

PAS Helps Prisoner Transfer Away from Childhood Abuser

A male prisoner, who had suffered sexual assault and rape as a child, contacted us via the Advice Line after he was placed in the same prison as his rapist, who was serving a sentence for the abuse committed on the prisoner.

At the time of the rape, the prisoner was known by a different name. This meant that the prison alert system had not been activated when housing the prisoner, and that – as a result – the prisoner was having to encounter his abuser on a daily basis. This was understandably traumatic. The prisoner had requested transfers to seven other prisons, but these were all rejected. He then asked

We contacted the prison, reminding them of their duty of care to the prisoner, and that prisoners are entitled to the same protections as any person in the community. We also asked them to explain why the prisoner's transfer requests had all been refused and what steps the prison was taking to ensure that the prisoner did not encounter his abuser. The prison informed us that they had only been able to apply to two of the institutions the prisoner had requested due to a lack of transport – and were still waiting to hear from them. PAS pointed out the urgency of the situation and asked that everything be done to move the prisoner as soon as possible.

The prisoner was then permitted to transfer to an alternative prison. Transport was organised and booked for him to move there.

Outreach Resumes: A Visit to HMP Downview

With the lifting of Covid restrictions in PAS has prisons. been aiven permission to re-enter some prisons and restart Outreach Clinics. These clinics are held inside prisons and allow caseworkers to meet with prisoners face-to-face to discuss any legal issues or problems they may have. I was fortunate to attend a recent clinic in women's prison, HMP Downview (Sutton), with Women's Prisoner Caseworker. It was my first visit to a prison and a very eye-opening experience.

I arrived at HMP Downview at 8.30am. The clinic is held in the prison library and I passed through what felt like at least ten locked gates before reaching the library. Our caseworker and I had nine women registered to attend the clinic and got straight into the first meeting as time

The Return of the PAS Annual Lecture

July saw the return of the PAS Annual Lecture series after a break of nearly three years, and PAS, with the support of Reed Smith, was delighted to host the in-person event after it's hiatus during the pandemic. Matthew Evans, Director of The AIRE Centre and former managing

was limited. Each prisoner's situation is unique and the issues they face are many and varied; from access to adequate mental health services and difficulties accessing food suitable for medical conditions, to procedural issues such as requests to view information held personal HMPPS. The common thread I found during the appointments is that prisoners, through no fault of their own, just do not have enough information regarding the prison system or processes, legal otherwise. This was the case with a number of women I met who all had questions relating to the ROTL (Release on Temporary Licence) process in the run up to their eventual release. Our caseworker clearly advised them on the process and their legal rights, and after the clinic, each service-user will receive a follow up letter clarifying the information and often including a PAS Toolkit or Information Sheets.

Of clinics, Women these our Prisoners' Caseworker says, 'It's fantastic to have Outreach Clinics back up and running. It's a vital service that enables those women who may be wary of speaking over the telephone in a public place, to talk freely and privately and to access the advice, help and support they need. It's important to listen with compassion to every woman who comes to see us as the issues faced often by these women are multifaceted, encompassing prison, human rights and family law.'

solicitor at PAS, delivered a thoughtprovoking lecture entitled, 'What about OUR Human Rights?' The lecture discussed the now normalised notion that Human Rights protect the individual over society and rights are linked to your participation in society rather than being fundamental. Stepping up for Justice – the London Legal walk


